Product Description

SPUR+ 1020 prepolymer is a silylated polyurethane resin which can be used in manufacturing one-part, moisture-curing sealants and adhesives. Plasticizer-free and of relatively low viscosity, it is an excellent candidate as a base resin for low modulus sealants in building and construction applications where elastic recovery is required. Its clear appearance and excellent color stability can typically allow formulators to create optically clear sealant products.
